The RKI makes the health mafia: Justice joins

It is thanks to the persistent work of the Multipolar magazine that one of the many smuts of the RKI (Robert Koch Institute) has become public. The magazine's colleagues have forced the disclosure of the Corona protocols with a lawsuit. From the more than 1,000 pages of the protocols of the RKI crisis member, it is clear that this extended arm of the pharmaceutical industry – e.g. the on the 22. March 2020 had imposed lockdown – completely arbitrarily. On the 17th In March 2020, the RKI upgrades the risk assessment for the health of Germans from “mode” to “high”. The day before, the documents noted that the new risk assessment has been prepared and should now be “highly scaled”: “The risk assessment will be published as soon as (personal name blackened) gives a signal for it.” The decisive actor makes the RKI unrecognizable.

Defamed as right Schwurbler

The Robert Koch Institute is a federal agency under the health minister. If the ministry did not take action after the scandal was published, the federal prosecutor would now have to intervene. An authority with unprecedented restrictions on fundamental rights harassing the population: daycare centres and schools were closed, there were prohibitions of visits to retirement homes and general initial restrictions. Public life came to a standstill. And anyone who dared to question the measures critically was defamed as a “right Schwurbian”. In unity with the constitutional protection, a lot of pseudo-leftists set out on the warpath; among them the RRRRRevolutionaries of the “Young World” and the “New Germany”. Where is the public apology? Analysis? Zero times zero so far!

Malt deceit for the purpose of profit-making

But it would be more interesting than the confessions of the fake left if the Minister of Health or the Public Prosecutor were to make the blackened name of the person responsible known as quickly as possible. The RKI is subsidised with 108 million euros annually from taxpayers' funds. The ministry could reach the immediate revelation of the name with a telephone call. Instead, it participates in the cover-up of crimes: among other things, the deprivation of liberty of the population, the torture of children and the fraudulent deception for the purpose of profit.

You don't know honor

From the mass media of the Federal Republic – from the private to the public-rights – at least a self-critical processing would be due: day after day, they maltreated their consumers with epidemic numbers, even though there was no epidemic and the figures were made by a fraudulent institute by manipulation. A grateful public would also like to accept this or that suicide as a sign of repentance. But the ladies and gentlemen of the media can only stop their hands, there is no such thing as honour.

Institute for Spray Harms

At the start of redress, the RKI could begin to collect and publish the harmful consequences of the gene injections enforced by a mass-panic. The many victims and their survivors need a proper legal basis for the processes due. If the RKI refuses to take on this task, it would be time to dissolve an institute that has long been stained the name of Robert Koch and has become part of the medical-industrial complex.

Methods of mass fraud

The apparent “fight against the virus” was a very important preliminary exercise for the “fight against the Russian”. The Corona regime has tested what the Germans can be expected to ly. Since it has been clear that almost everything is swallowed, the successful methods of mass fraud are also used for war propaganda.

It's about life and death

It was possible to effectively expose the Corona mass fraud, there would be a first big lever to bring down the government, industry and mass media building. The extra-parliamentary opposition must concentrate on this, the alternative media must concentrate on. It is about life and death, about war or peace.
