**Documents** are to be presented for adoption at the 77th World Health Assembly in May 2024.

For the changes of the international Health regulations require one

**simple majority**. As a result, the regulations come into effect within 12 months applicable to all states. The Pandemic Agreement requires a 2/3 majority to pass. Thereafter, each WHO member state can sign and ratify the treaty according to the procedures provided for in their national law.

The results of these negotiations will affect the lives, health and human rights of people around the world.

Confer the proposed changes the WHO and thus the Director General unique "emergency" powers.

# Top 10 reasons not to change international HEALTH REGULATIONS

## » CHANGE FROM ADVISORY TO BINDING

Changing the character of the World Health Organization from an advisory organization that only makes recommendations to a governing body whose statements are legally binding. (Article 1 and Article 42)

## » POTENTIAL EMERGENCIES INSTEAD OF ACTUAL EMERGENCIES

The scope of the international health regulations is greatly expanded to include scenarios that only have the potential to affect public health. (Article 2)

## » CONTEMPTATION FOR DIGNITY, HUMAN RIGHTS AND FREEDOM

Respect for human dignity, human rights and fundamental freedoms should be abolished. (Article 3)

## » DISTRIBUTION PLAN

The Director-General of the WHO is to be given control of the means of production through a "health product allocation plan" to oblige States parties to deliver products to combat the pandemic as required. (Article 13A)

## » MANDATORY MEDICAL TREATMENTS

WHO will be given the power to require medical examinations, proof of prophylaxis, proof of vaccine and the implementation of contact tracing, quarantine and medical treatment. (Article 18)

## » GLOBAL HEALTH CERTIFICATES Introduce a system

of global health certificates in digital and paper form, including medical examination certificates, vaccine certificates, prophylactic certificates, recovery certificates, traveler locator forms and a traveler health statement.

(Articles 18, 23, 24, 27, 28, 31, 35, 36 and 44 and Annexes 6 and 8)

## » LOSS OF SOVEREIGNTY

Would empower the Emergency Committee to overrule public health decisions of sovereign countries and make the Emergency Committee's decisions binding. (Article 43)

## » INCALCULABLE COSTS

The WHO reserves the right to distribute billions of dollars to the hospital-emergency pharmaceutical industrial complex without accountability. (Article 44A)

## » CENSORSHIP

Significantly expand the World Health Organization's ability to censor what the WHO sees as misinformation and disinformation. (Appendix 1, page 36)

## » COMMITMENTS TO COLLABORATION

Creates an obligation to set up, provide and maintain IHR (International Health Regulations) infrastructure at points of entry. (Appendix 10)
