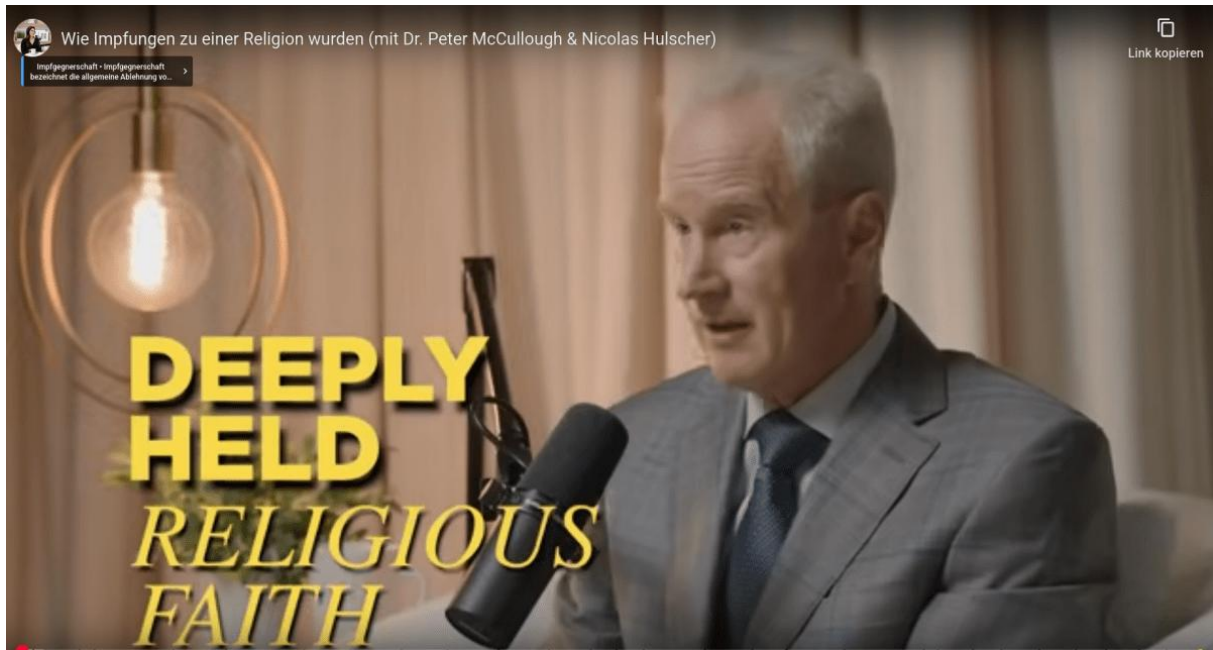




The world's biggest false religion: vaccines

I. The “Religion of Vaccines”

- **Deeply ingrained belief:** Dr. McCullough explains that most doctors, medical associations, and societies have a “religious belief” that vaccines are inherently good and must be accepted, with any questioning leading to efforts to “annihilate” those who think differently.
- **Historical roots:**
 - **Cotton Mather (1721):** Mather, a Puritan minister in Boston, promoted variolation (an early form of smallpox vaccination) as a “gift from God” out of fear of infectious diseases after losing his children to measles, and associated vaccination with divine intervention from the outset. He also served as an advisor during the Salem witch trials.
 -
 - **Louis Pasteur:** He was accused of making bold, unfounded claims and fraudulently withholding his notes. Later revelations in the 1960s showed that his work was not as he had portrayed it and that he had stolen from others.
- **Modern iconography:** A papal coin issued by Pope Francis depicts a child receiving a vaccination instead of the Eucharist, explicitly symbolizing that vaccination is replacing a central sacrament of Christianity. Banners in churches, such as one in New Zealand reading “Not even the blood of Jesus Christ can save you, get vaccinated,” illustrate this “competing religion” even more clearly.

II. Historical concerns regarding vaccines and lack of transparency

- **Polio vaccines:**
 -
 - **Cutter incident:** Early injectable polio vaccines were contaminated with live polioviruses, causing some children to contract polio.
 - **SV40 contamination:** It was later discovered that polio vaccines were contaminated with fragments of Simian Virus 40 (SV40), DNA known to promote cancer. The Institute of Medicine confirmed this and acknowledged that there are unknown long-term cancer risks for vaccinated individuals.
 - **A dubious narrative on eradication:** The speakers suggest that the decline in polio cases could also be attributed to improved hygiene, since the first oral polio vaccines contributed to the spread of the virus in the water supply. They argue that the individual benefit of a vaccine is theoretical if one never comes into contact with the disease, while the side effects are real.
- **Measles vaccine (MMR):**

- **Safety vs. Benefits:** While measles vaccination can prevent infection, the safety (especially of combined MMR vaccines) is questioned, as the risks may outweigh the benefits for many.
- **Untested combinations:** The current childhood immunization schedule includes 72 doses for ages 0 to 18, none of which have been tested for safety in combination, leading to ongoing legal action against the HHS for failing to submit required safety reports.
- **Adverse events:** Over the past 20 years, the Vaccine Adverse Events Reporting System (VAERS) has received reports of more deaths from the MMR vaccine than from measles. One case is cited in which a baby died from the attenuated live measles vaccine due to an undiagnosed immunodeficiency.
- **Ineffectiveness:** Dr. McCullough has no immunity despite four measles vaccinations, and Dr. Ben Edwards, also vaccinated, contracted measles from unvaccinated Mennonite children.
- **Misleading reporting by the CDC:** The CDC's "vaccination status unknown" classification for measles outbreaks is criticized as an attempt to obscure the vaccination status of many people who have been vaccinated but have no proof of it.
- **Treatment options:** Measles can be treated with immunoglobulin, vitamin A, antibiotics and corticosteroids.

III. Data on unvaccinated children and the suppression of dissenting opinions

- **Healthier unvaccinated children:** Studies by Mawson and colleagues (40,000 Medicaid recipients in Florida) and Dr. Paul Thomas (5,000 pediatric patients), as well as observations in Amish communities, show that healthy children who do not receive vaccinations are generally healthier and less likely to suffer from autism, neurodevelopmental disorders, autoimmune diseases, and asthma.
- **Professional retaliation:** Dr. Paul Thomas had his medical license revoked because he addressed and published on vaccine safety in his practice, even before COVID-19 emerged. This illustrates the suppression of research that challenges the "vaccine religion."
- **Financial incentives:** Reimbursements to doctors by insurance companies and government agencies are tied to the percentage of vaccinated patients in their practice, creating a financial incentive to promote vaccinations.

IV. COVID-19 mRNA vaccines: Unprecedented harm and lack of oversight

- **Gene transfer platforms:** The speakers do not classify mRNA injections as traditional vaccines, but rather as "gene transfer platforms".
- **“ Transcriptomic chaos”:** Studies by the McCullough Foundation and Neo7 Bioscience revealed severe dysregulation of thousands of genes after mRNA injections in injured individuals, including the switching off of tumor suppressor genes (p53, BRCA), leading to “turbo cancer”.
- **“ Proteomic chaos”:** Defective proteins (fibrin, amyloid) are produced, leading to “rubbery” blood clots and possible links to dementia and Alzheimer’s disease.
- **Widespread adverse events:** The “numerous problems” include cardiovascular, neurological and thrombotic problems, as well as cancer.
- **Estimated deaths:** The estimated number of deaths in the US from mRNA vaccines is between 500,000 and 600,000.

- **Astonishing lack of oversight:** Despite the widespread deaths and adverse events, no country has conducted a safety review, nor have the vials been tested for quantity, purity, or impurities.
- **Normalization of damage:**
 - **Strokes in children:** A bus in Great Britain allegedly carried a sign saying "Children also have strokes" in an attempt to normalize an abnormal event.
 - **Autism ("neurodiversity"):** The CDC has pushed back the milestones of child development, and there is a societal normalization of autism, which has been renamed "neurodiversity." A proposal from the New England Journal of Medicine is cited to specifically recruit autistic individuals for medical school in order to address the growing number of autistic patients, despite awareness of the potential difficulties these individuals face with medical demands.
 - **Portrayal in "The Chosen":** The character Matthew in "The Chosen" is portrayed as autistic, although there is no historical basis for this, which further promotes normalization.

V. The Transgender Crisis and Genetic Manipulation

- **Association with autism:** An estimated high percentage (40–50%) of transgender people are autistic, making them vulnerable to clinics that offer "gender-affirming treatments".
- **Harmful interventions:** These clinics reportedly administer SSRIs (which have been linked to increased homicidal behavior), synthetic hormones (which alter the psychological profile), and perform irreversible surgeries, all of which increase the risk of homicide, suicide, and overall mortality.
- **Complicity of medicine:** Dr. McCullough expresses his outrage that "reputable institutions" like Harvard have transgender medical departments without proper review or ethical examination.
- **Legal challenges and violations:** Despite bans on gender-affirming treatments for adolescents (e.g., in Texas, supported by Dr. McCullough), doctors at institutions such as UT Southwestern have allegedly violated the law.
- **Permanent damage:**
 - **Lupron (puberty blocker):** A single injection can permanently impair a child's mental development.
 - **Surgical procedures:** Breast amputations in girls cause complications such as drainage problems and contractures. Penile inversion vaginoplasty in boys (the penis is cut out and inverted into the pelvis) leads to severe dysfunction, infections, and the inability to function as a sex organ.
- **Confirmation of biological sex:** Dr. Miriam Grossman advocates for "sex confirmation," in which a child's biological sex is confirmed early on to counteract the "perverse transgender path" to which children are exposed.

VI. Transgenerational Damage and Data Confidentiality

- **Infant and maternal mortality:** CDC data show a statistically significant increase in infant mortality (77% higher in 2025) and maternal mortality (record high in 2021, with 20% of deaths due to cancer) since the mass vaccination of women of childbearing age in early 2021.
- **Genetic inheritance:** Concerns are raised about the possibility that mRNA vaccine material could be integrated into the body and cause "transgenerational damage".

- **Data suppression by the CDC:** The CDC is criticized for keeping vaccine data secret and refusing to merge it with other public health registries (cancer, autism, cardiovascular disease, mortality) to prevent researchers from fully uncovering vaccine safety concerns.
- **“Vaccine skepticism as a disease”:** Medical literature, including the “Oxford Scale of Vaccine Skepticism”, now considers vaccine skepticism as a disease in its own right, highlighting the extreme nature of the “vaccine religion”.
