


# Soros, Central Europe and the 'Heartland' theory

In several Eastern European countries, national conservative governments are coming under pressure from mass protests and Western media campaigns. NGOs are exerting targeted influence under the guise of accusations of corruption and criticism of the regime.

## **Destabilization of Eastern European national-conservative governments**

The Czech Nečas government (July 2010 - June 2013) was toppled with similar allegations of corruption <u>as in Hungary</u>. Mass demonstrations were also mobilized against the then Czech Prime Minister Babiš (2017 - 2021), an avowed Orbán supporter, which were eagerly supported by the Western mainstream media: "<u>This is the largest demonstration</u> since the 'Velvet Revolution' of 1989."

The same scenario played out in August 2020 against the Bulgarian government, which the demonstrators see as a "<u>mafia-oligarchic ring</u>".

Likewise in July 2020 against the Serbian government: "Critics see this as the <u>beginning of an</u> <u>uprising against the rule</u> of President Vučić." (DW)

In this respect, however, all these so-called 'color revolutions' remain subversively dangerous, namely as arbitrary beacons of facade democrats: because they are kept simmering for as long as they like with unlimited funding from the Soros network. True to Goebbels' motto: "You only have to repeat a lie long enough for people to believe it."

## Serbia is under attack

In the case of Serbia, these subversive coup attempts escalated at the beginning of 2024, with the most flimsy pretexts being recruited: in May 2023, for example, there had been several armed rampages in Serbia with 18 deaths, with the "tens of thousands" of Soros-colored revolutionaries sensibly blaming President Vučić, including the entire national-conservative government and the <u>tabloid media allegedly controlled</u> by it: "According to critics", these are supposed to "incite hatred and glorify violence".

A comparison: between November 1999 and February 2024, there were a total of 16 rampages in Germany with a total of around 90 serious injuries and many deaths - and "only" at educational institutions. Of course, there have never been any large-scale organized "color revolutions" against the German systemic parties.

## **Reproaches from the West**

The totalitarian and pronounced anti-democratic agitation of the Deep State can then inevitably be recognized by this: When Serbian President Vučić won early elections in December 2023 with a clear 46 percent of the vote, Western system media immediately "located" "violations and fraud": Color subversives are then reframed as "critics" who "accuse Vučić of an <u>authoritarian</u> style of government" (ORF). - Mind you: after Vučić won the early election he had called with an overwhelming majority for the national-conservative government.

In spring 2024, protests escalated in Georgia against the legitimately elected government because it had passed a so-called "agent law" in parliament with a clear majority, which regulates the financing of Georgian NGOs by foreign donors above a level of 20 percent.

## Anglo-American Mackinder geostrategy to destabilize Ukraine

Is this a continuation of the doctrine of the English geostrategist Mackinder from 1904? Namely the "domination of the world island of Eurasia" by an Anglo-Saxon power? And to reorganize the Balkans under compliant left-liberal governments?

The ideological basis of a hostile policy against European Central Europe was in fact the study "The Geographical Pivot of History" published by Halford Mackinder in London in 1904. In it, he describes the political, economic and strategic superiority of a continental power over naval powers.

## Whoever rules Eastern Europe rules the "heartland"

Mackinder's "Heartland" theory states in detail: Whoever rules the "Heartland" rules the largest world island, namely Eurasia. Whoever rules over this world island rules the whole world. Of course, this would have meant that Great Britain's position of global power would have been threatened by the rising continental powers in Europe - Germany, France, Austria-Hungary and Russia. In this respect, however, Mackinder saw the importance of Central and Eastern Europe as a source of danger for London that had to be eliminated or controlled.

In this sense, the American political scientist George Friedman also admitted in a lecture in March 2015 that this theory - which is still taught at military academies in the USA today - has been the basis of American foreign policy for 100 years. It is about preventing a Eurasian continental power. In concrete terms, cooperation between Germany and Russia had to be prevented. The importance of Central and Eastern Europe should also be seen in this light, as a buffer zone to prevent a connection with Russia or China.

All world wars, including the current war in Ukraine, can be traced back to the Mackinder theory, or were based on it. The result: the prevention of a merger of European continental powers. And Ukraine is also currently the "heartland" that the USA is trying to seize from Russia.
