

Trump advisor Musk: USAID created Covid-19 with US taxpayers' money and murdered millions



Elon Musk, the world's richest man and one of US President Donald Trump's most influential advisors, publicly announced on February 2: "Did you know that USAID used YOUR tax dollars to fund bioweapons research, including COVID-19, that killed millions of people?" The silence of the left-wing mainstream media worldwide is deafening.

The Trump administration is apparently planning the complete dissolution of the United States Agency for International Development, or USAID for short. It was a CIA front organization that was used to overthrow governments worldwide - but also to spread and enforce the far-left agenda of the "Democrats"

In the course of this, the atrocities for which USAID is responsible are becoming increasingly known. Left-wing unified media are in shock, apparently many were also on the list of direct or indirect recipients of money. They are trying a so-called "spin" by claiming that it was a humanitarian aid organization.

In reality, however, the CIA financed and operated dozens of bioweapons laboratories worldwide via USAID. This apparently includes the development of Covid-19 in China. This is said to have happened via the further detour of the EcoHealth Alliance, which received 53 million US dollars from USAID - and an additional 42 million from the Department of Defense (DOD).



USAID channeled \$53 million to EcoHealth Alliance, which then used U.S. taxpayer money to support gain-of-function research on coronaviruses at the Wuhan lab - research that likely led to the emergence of COVID-19.

The CIA's attempts to deceive about the origins of COVID-19 become much clearer when one considers USAID's long history as a CIA front organization.

With an annual budget of over 50 billion dollars and activities in over 100 countries, USAID has repeatedly been linked to intelligence activities. Former USAID Director John Gilligan

once admitted that the agency was "infiltrated from top to bottom with CIA people," explaining, "The idea was to infiltrate agents into every kind of activity abroad: governmental, volunteer, religious, every kind."

In 2013, a US dispatch published by WikiLeaks described the US strategy to undermine the Venezuelan government through USAID by "penetrating Chávez's political base", "dividing Chavism" and "isolating Chávez internationally".

In 2014, the Associated Press revealed that USAID funded the creation of a Twitter-like platform designed to incite an uprising in Cuba.

USAID funding has been linked to coups in Haiti, Ukraine, Egypt and other countries.

From 2009 to 2019, USAID partnered with EcoHealth Alliance on the PREDICT program, which identified 1,200 new viruses, trained 5,000 people worldwide in disease detection and expanded 60 research labs.


This partnership provided a direct channel for the CIA to infuse human capital into biological research facilities worldwide in exchange for funding and technology transfers.

In 2022, Dr. Andrew Huff, former Vice President of EcoHealth Alliance, revealed Dr. Peter Daszak's alleged ties to the CIA.

The core problem?

The CIA lied to the American public about the origins of COVID-19 because revealing the truth would expose its likely role in funneling taxpayer money through USAID to fund gain-of-function research at the Wuhan lab.

The "Milla Joy" account stated that there was direct evidence that the NIAID used USAID funds to finance a scientist in Wuhan who was researching "bat coronaviruses". This very scientist became the first known Covid patient.



The fact that these facts are neither reported nor investigated proves that the so-called "established media", which call themselves "quality media", are the lowest scum of the journalistic guild and that their actions are to the detriment of the people. All state funding for such media must be stopped immediately.
